Whereas, the final seniority list of Gazetted Officers of the Soil Conservation Department was last issued vide Government Order No. 461-FST of 2010 dated 13.12.2010; and

Whereas, after issuance of the said seniority list, some members of the service have retired and some other have been promoted to the next higher posts. Besides, some appointments through PSC have also been made; and

Whereas, as a result of the above changes, it has become necessary to update and notify the fresh seniority of Gazetted Officers of the Soil Conservation Department by deleting the names of those officers who have either retired from the service or expired and by adding those who have been appointed under direct recruitment quota and also by incorporating the names of those officers at appropriate places who have been promoted to the Gazetted Service subsequent to the date of issuance of the last seniority list of Gazetted officers of Soil Conservation Department viz. 13.12.2010; and

Whereas, an updated tentative seniority list of Gazetted Officers of Soil Conservation Department as it stood on 01.03.2013, was issued vide Notification No. FST/SC/Seniority/07/2013 dated 05.04.2013 for information of all the members. It was also notified that any officer not satisfied

with the position assigned to him/her in the tentative seniority list may represent to the Administrative Department through Director, Soil Conservation Department with documentary evidence within a period of 15 days; and



Whereas, the Administrative Department examined the said representation and was find devoid of merit.

Now, therefore, final seniority list of the Gazetted Officers of the Soil Conservation Department as it stood on 01.03.2013 is hereby notified for information of all the concerned.

It is further notified that:-

- a) Review petition by the officers, if any, against the position assigned to him/her in the seniority may be made to the competent Authority within 15 days time from the date of issuance of the Government order, after which no petition, whatsoever, shall be entertained.
- b) Date(s) of birth indicated against the officers in annexure to this order shall not be treated as authentic for the purpose of determination of age which shall and shall always have reference to the recorded date of birth in the Service Book on the basis of the matriculation certificate issued by the competent authority.
- c) The officers belonging to any reserved categories may also submit valid category certificate afresh within the prescribed time period.



- d) This issues without prejudice to the outcome of the Writ Petition(s), if any, on the subject pending before any Competent Court of law.




